- 55.9% of all myMatrixx prescriptions in 2020 were transmitted to the pharmacy utilizing electronic prescribing
- E-prescribing has now increased 7.6% year over year
- Group health care estimates an 80 to 86% adoption rate for e-prescribing, leaving a high margin for improvement in workers' compensation
- New regulations requiring e-prescribing for all opioids and controlled substances will drive new adoption across the workers' comp industry



Curbing potentially dangerous prescriptions right in the doctor's office

As e-prescribing continues to develop, it will offer the possibility to transfer key clinical interventions from the point of sale to the point of prescription, promoting patient safety. The goal is to enable physicians and our clinical team to work together to identify potentially dangerous drugs, and life threatening drug combinations, such as opioids and benzodiazepines.

myMatrixx pharmacists will be available for consultation at any time to explain potential issues with a patient's drug regimen and develop a plan for intervention.



E-prescribing process

Instead of using traditional paper prescriptions, prescribers create prescriptions within their practice management software oftentimes while the patient is still in the exam room.

- Next the prescriber is notified of typical formulary concerns avoiding the possibility that non-related Rx's are not processed through workers' compensation
- The physician then submits the prescription directly to the pharmacy from their computer or smart device
- Accuracy and safety are both enhanced with the electronic process versus traditional paper prescriptions
- Delays at the pharmacy counter are minimized or avoided altogether improving the injured worker experience
